#### **Hon'ble Chief Guest**



#### **DISTINGUISHED FOREIGN & INDIAN HON'BLE JUDGES**



Hon'ble Mr. Justice Antonio Herman Benjamin

National High Court of Brazil (STJ) and President,

Global Judicial Institute on the Environment

Appointed Justice of the National High Court of Brazil (STJ) in 2006 by President Luiz Inácio Lula da Silva, Professor Antonio Herman Benjamin has been a career Assistant Attorney General of the State of São Paulo for over twenty years, where he headed the Environmental Protection Division for several years. In 2015, Justice Benjamin was appointed Justice of the Superior Electoral Tribunal of Brazil (TSE), having acted as its Electoral Inspector-General ever since. Justice Benjamin was the founding President of both the Brazilian Consumer Law and Policy Institute and Law for a Green Planet Institute.



Luc Lavrysen is an environmental law professor at Ghent University, where he leads the Centre for Environmental and Energy Law. He is also the president of the EU Forum of Judges for the Environment and has worked with UNEP on the role of the judiciary. Professor Lavrysen is a Founding Member of the Global Judicial Institute on the Environment and he is currently on the Interim Governing Committee.




Hon'ble Mr. Justice Brian Preston

Chief Judge of the Land and Environment Court of New South Wales.

Justice Preston is the Chief Judge of the Land and Environment Court of New South Wales. Prior to being appointed in November 2005, he was a senior counsel practising primarily in New South Wales in environmental, planning, administrative and property law. He has lectured in post-graduate environmental law for over 25 years. He is the author of Australia's first book on environmental litigation and 103 articles, book chapters and reviews on environmental law, administrative and criminal law.



Justice A.H.M.D.Nawaz was an all counsel and represented Sri Lanka in both civil and criminal litigation when he was a Deputy Solicitor General in the Attorney General's Office. He was elevated to the Court of Appeal of Sri Lanka in 2014 and later as its President in 2020. In the same year he was elevated to the Supreme Court of Sri Lanka-the apex court. Justice Nawaz is both a British Chevening Scholar and a Fulbright Humphrey Fellow.






Hon'ble Justice Nallini Pathmanathan

Judge, The Federal Court of Malaysia

Justice Nallini Pathmanathan is a judge at the Federal Court of Malaysia and the Chairperson of The Malaysian Middle Temple Alumni Association. She has personally interacted with judges from the United Kingdom via the Standing International Forum of Commercial Courts.

The judiciary in Malaysia enjoys close links with the United Kingdom and its judiciary.



Dr. Justice Ananda Mohan Bhattarai completed his Doctor of Jurisprudence (J.S.D.) from National Law School of India University in 2000. He went to Massachusetts Institute of Technology, USA (2002-2003) under the Hubert H. Humphrey Fellowship for a program on law, human rights and public policy at the Department of Urban Studies and Planning, Special program for Urban and Regional Studies of Developing Areas.



Hon'ble Mr. Justice Michael D. Wilson

Judge, Supreme Court of Hawaii

Justice Wilson was appointed to the Hawaii Supreme Court on April 14, 2014, for a term set to expire on April 16, 2024. Prior to being appointed to the Hawaii Supreme Court, Wilson served as a Circuit Court judge for the Hawaii First Circuit. He previously served as the director of the Hawaii Department of Land and Natural Resources, chair of the Board of Land and Natural Resources, chair of the State Water Commission and a trustee of the Kahoolawe Island Reserve Commission. Justice Wilson holds an undergraduate degree from the University of Wisconsin a JD (Doctor of Jurisprudence) from the Antioch School of Law.



UN Resident Coordinator in India

Mr. Shombi Sharp is an American diplomat with the United Nations, UN Resident Coordinator in India Mr. Sharp is the direct representative of the UN Secretary-General and highest ranking UN official based in the country, carrying a diplomatic rank equivalent to Ambassador of a foreign state. He also serves as Designated Official for Security of the UN system in the country.





Hon'ble Justice Sanjay Krishan Kaul

Judge, Supreme Court of India

Justice Sanjay Kishan Kaul graduated in Economics (Hons.) from St. Stephens College, Delhi University in 1979 and obtained his LL.B. Degree from The Campus Law Centre, Delhi University in 1982. In the same year, he enrolled as an Advocate with the Bar Council of Delhi. Kaul J practised mainly in the Commercial, Civil, Writ, Original and Company jurisdictions of the High Court of Delhi and the Supreme Court of India. Kaul J became an Advocate-on-Record of the Supreme Court of India in 1987 and was designated as a Senior Advocate in December 1999. He was appointed Senior Counsel for the Delhi High Court and the Delhi University. He was also on the Senior Panel of the Union of India and served as the Additional Senior Standing Counsel for the DDA.

Judge, Supreme Court of India



Justice Bhushan Ramkrishna Gavai is a Judge of the Supreme Court of India. He was Standing Counsel for Municipal Corporation of Nagpur, Amravati Municipal Corporation and Amravati University, and was also appointed as the Assistant Government Pleader and Additional Public Prosecutor in the High Court of Judicature at Bombay, Nagpur Bench, from August, 1992 to July, 1993. He was, later, appointed as Government Pleader and Public Prosecutor for Nagpur Bench in the year 2000. Elevated as Additional Judge of the High Court in 2003.





Hon'ble Justice Surya Kant

Judge, Supreme Court of India

Justice Surya Kant is a judge of the Supreme Court of India. He had studied law at the Maharshi Dayanand University in Rohtak. He began practising in the Punjab and Haryana High Court in 1985 and served as the Advocate General of Haryana. He was then designated as a Senior Advocate in 2001. In 2004, Surya Kant J was appointed as a Judge of the Punjab and Haryana High Court. He was sworn in as the Chief Justice of Himachal Pradesh High Court on October 3rd, 2018.



Chief Justice of Himachal Pradesh High Court

Justice Mohammad Rafiq is the Chief Justice of Himachal Pradesh High Court. He is former Chief Justice of Madhya Pradesh High Court, Orissa High Court and Meghalaya High Court and also former Judge of Rajasthan High Court.

He has served twice as the Acting Chief Justice of Rajasthan High Court, and is also currently serving as the Chancellor (ex-officio) of Himachal Pradesh National Law University, Shimla.





Justice Ritu Bahri
Judge, High Court of Punjab and Haryana

Justice Ritu Bahri enrolled herself as an Advocate in the year 1986 with Bar Council of Punjab & Haryana and started her practice in Punjab & Haryana High Court. She was appointed as Assistant Advocate General, Haryana, in March 1992, thereafter, as the Deputy Advocate General, Haryana, in August 1999 and Senior Advocate General, Haryana, in December 2009. While representing the State of Haryana, she handled several cases relating to Service matters, land Acquisition, Taxation, Revenue, Labour cases and MACT cases. She was elevated as Judge of the Punjab & Haryana High Court on August 16, 2010.



Judge of Punjab & Haryana High Court

Born on March 12, 1963 at Ropar [Punjab]. After initial schooling in St.Mary's Convent School, Kasauli (H.P.), completed school education from Saifuddin Tahir High School, Aligarh. Graduated in Science [Honours] and then LL.B. (Hons.) from Aligarh Muslim University at Aligarh. Enrolled as an Advocate on the rolls of Bar Council of Punjab & Haryana Bar Council on June 06, 1987. Practiced on both Original and Appellate sides in the field of Constitution Law, Service Law, Labour Law, Civil Law, etc. Also appeared in the Supreme Court, High Courts of Punjab and Haryana, Delhi, Himachal Pradesh, and various other Courts and Tribunals. Held the posts of Assistant Advocate General, Deputy Advocate General, Additional Advocate General in the office of Advocate General, Punjab. Sworn in as Additional Judge of Punjab & Haryana High Court on July 10, 2008 and as a Permanent Judge on January 14, 2011.



**Justice Sabina** 

Judge High Court of Himachal Pradesh

Justice Sabina was selected as the Joint Secretary of Bar Association of the Punjab and Haryana High Court in the year 1986. She, thereafter, joined as an Additional District Judge in 1997. She subsequently became Sessions Judge in 2004 and was, thereafter, elevated as an Additional Judge of Punjab and Haryana High Court in 2008 and Permanent Judge in 2010. She later served as a judge of the Rajasthan High Court in 2016. In 2021, she took oath as a judge of the High Court of Himachal Pradesh.



Judge of Punjab & Haryana High Court

Tracing his roots to a humble background, His Lordship joined LLB course in the Panjab University after his graduation in the year 1987 and enrolled as an Advocate with the Bar Council of Punjab and Haryana in the year 1990 as a first-generation Lawyer. In a practice stretching over three decades, His Lordship represented a wide range of institutions including The Punjab and Haryana High Court, Chandigarh Administration, various autonomous bodies including Punjab Urban Development Authority, Punjab School Education Board, Punjab Technical University, Guru Nanak Dev University amongst others. While in practice his area of expertise remained in dealing with Service, Civil, Election and Constitutional matters. An ardent sports enthusiast, he represented his College and University in the games of Basketball and Handball in various events at the time of his undergraduate degree.





Justice Jyoti Singh

Judge High Court of Delhi

enrolled herself with the Bar Council of Delhi. And started Practicing before the Hon'ble Supreme Court, the High Court of Delhi and several Tribunals. She was appointed as a Senior Counsel for the Government of India in the High Court of Delhi, Standing Counsel for the Union Public Service Commission, Standing Counsel for the DTC, Standing Counsel for Delhi Government in Central Administrative Tribunal, Additional Standing Counsel for NDMC and as a Panel Counsel for Provident Fund, DDA and Canara Bank. She was a member of the Delhi High Court Legal Services Committee and participated in Lok Adalats and workshops organised by the Committee.



Justice Najmi Waziri enrolled with the Bar Council of Delhi in 1987. Practiced before the Hon'ble Supreme Court of India, the High Court of Delhi, other High Courts and various tribunals and quasi judicial fora. Appointed: Standing Counsel (Civil), Government of National Capital Territory of Delhi; Central Government Pleader in the Delhi High Court; Standing Counsel, Delhi Wakf Board; and Standing Counsel, Municipal Corporation of Delhi.



Justice Anupinder Singh Grewal

Judge of Punjab & Haryana High Court

Started his practice in 1992 at the Punjab & Haryana High Court. He was appointed as an Assistant Advocate General, Punjab from 1995 to 1997; then as the Deputy Advocate General from 1997 till his re-designation as the Senior Deputy Advocate General in 2002 and worked as such till 2005. He was appointed as the Additional Advocate General, Punjab from 2005 till his elevation as a judge of the Punjab and Haryana High Court. He has been a part of several important cases pertaining to Civil, Constitutional, Criminal, Service, Land Acquisition, Public Interest Litigation, for over 19 years on behalf of State of Punjab. He was appointed as Central Government Counsel in 2007 for conducting cases before Punjab & Haryana High Court and appeared in important cases for Union of India including LPAs, CEA, Arbitration cases, etc.



Judge of Punjab & Haryana High Court

Justice Amol Rattan Singh enrolled himself as an Advocate in 1985., thereafter, was appointed as Additional (Junior) Counsel for the State of Haryana at the Supreme Court of India in 1994, and an Assistant Advocate General, Haryana in June 1995 and Deputy Advocate General, Haryana in 2004. In the above capacities he handled all kinds of litigation for the State in Civil and Service matters, in the High Court and Central Administrative Tribunal, Accident Claims, Public Interest litigation, Land Acquisition, Service matters, Labour related matters, etc. Thereafter, he was appointed as Additional Advocate General, Punjab in 2005. He was then sworn in as an Additional Judge of the Punjab and Haryana High Court in 2012.

Before joining IUCN, she worked with the UNESCO- New Delhi Office as National Project Coordinator, World Heritage Biodiversity Program, India. She has also worked as Head, Regional Program on Himalayan High Altitude Wetlands Rivers, WWF-India. Ms Archana holds M.Phil and Masters in Environmental Sciences from Jawahar Lal Nehru University, New Delhi.

He is also the director in-charge of Gujarat Maritime University, Gandhinagar. Earlier, he was the pro vice chancellor and dean, School of Law at G.D. Goenka University, Gurgaon; founder dean, Faculty of Law at SGT University, Gurgaon; founder director of ITM Law School, ITM University, Gurgaon; founder director of MATS Law School, MATS University, Raipur; controller of examinations and associate professor of law at Hidayatullah National Law University, Raipur; senior lecturer at Government Law College, Madurai and Government Law College, Chennai. Before joining the legal academia he had practiced at the Madras High Court for seven years as an advocate.


